Dear Sir/ Madam,

The equity shares issued by our Company are listed on the SME Platform of BSE Limited.

With reference to above-referred SEBI Circular dated 19<sup>th</sup> November, 2018, we have to state that the Company will not be able to submit the Unaudited Standalone and Consolidated Financial Results for the half year ended 30<sup>th</sup> September, 2020, on or before the due date i.e. 14<sup>th</sup> November, 2020 due to the reasons mentioned hereunder:

- 1. Our Company is engaged into the business of transportation and having branches at many locations across India. In view of the situation prevailing due to COVID-19 pandemic, it has become difficult to update accounting records in time at some branches. Also, Air Travel required to various branches is not advisable in the current scenario. Further, the Company's Registered Office is situated in Navi Mumbai and our accounting staff is not able to attend the office in a normal manner in the prevailing situation due to COVID-19 pandemic and due to disruption of train services and hence, preparation of half yearly results will take some more time despite our best efforts.
- 2. Our Statutory Auditor Mr. Dhiraj Mehta could not attend his office for a long time due to prolonged sickness of his Father who finally passed away on 19<sup>th</sup> October, 2020. He had to also complete all rituals for 13 days post demise of his Father. In view of the same, review of accounts and preparation of Limited Review Report by the Statutory Auditors could not be completed in time.

However, the Company is making all efforts to submit the Financial Results on or before 30<sup>th</sup> November, 2020.
