Subject: Resignation as Statutory Auditors

Dear Sirs/ Madam,

We refer to our appointment as the Statutory Auditors of Shreeji Translogistics Limited ("the Company") at the Annual General Meeting held on 30th September, 2024, to hold office for a period of five years from the financial year 2024–25 to 2028–29.

We refer to your Company's decision not to accept our proposal for increase in audit and assurance fees for the statutory audit and limited reviews and further your Company has also asked us to continue the said assignments at same existing fees (as was applicable for FY 2024-25) for next 2 years i.e. FY 2025-26 & FY 2026-27.

As discussed earlier, we had expressed our concern to continue statutory audit including limited reviews with the same fees as was applicable for FY 2024-25, Our concerns in this regard were communicated to the Management as well as to the Chairperson of the Audit Committee. We understand that the matter has been duly deliberated by the Audit Committee and the Board of Directors.

In light of the above, and solely due to commercial reasons, we find ourselves unable to continue as the Statutory Auditors of the Company, as the current level of remuneration is not commensurate with the time, effort and costs required to discharge our duties in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India.

We wish to inform you that on 11th August 2025, we have discharged our obligation towards the Company by completing limited review for the quarter ended 30th June 2025, and have issued our Limited Review Reports on the Standalone and Consolidated Financial Results of the Company for the quarter ended 30th June, 2025.

Accordingly, we hereby tender our resignation as the Statutory Auditors of the Company. Please accept our resignation with immediate effect.
